

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to tiisolutions.com, and Tax Incentives Institute and governs data collection and usage. For the purpose of this Privacy Policy, unless otherwise noted, all references to Tax Incentives Institute include tiisolutions.com and TII. The TII website is a data driven marketing and information site. By using the TII website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Sharing Information with Third Parties**

TII may sell, rent, or lease customer information to third parties for the following reasons:

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. All such third parties are prohibited from using your personal information except to provide these services to TII, and they are required to maintain the confidentiality of your information.

### **Opt-Out of Sale or Disclosure of Personal Information to Third Parties**

### **Tracking User Behavior**

TII may keep track of the websites and pages our users visit within TII, in order to determine what TII services are the most popular. ### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by TII. This information can include: your IP address, browser type, domain names, access times and referring website address. ### **Use of Cookies**

The TII website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uTII that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

TII does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
